# Emergency lighting shows escape and rescue routes in an emergency



**Emergency lighting** allows people to safely exit a building in the event of a fire. It is usually separate from the general lighting and also provides protection against accidents in emergencies or when the normal lighting fails. If the general lighting fails, the emergency lighting must respond and provide light for a specified period of time. Emergency lighting systems are complemented by optical safety guidance systems that indicate a safe escape route through optical markings and directional information. These markings are either photoluminescent or electrical.

## The emergency lighting...

- ... **takes over the lighting of escape and rescue routes** in the event of a general power failure .
- ... **helps with orientation** during the escape through markings and directions .
- ... thus enables the rescue and escape of humans and animals.
- ... must be **professionally planned** and installed.

Emergency lighting must be planned in accordance with DIN EN 1838 and must therefore meet all requirements of this standard. ASRA 2.3 also specifies the conditions under which an emergency lighting system is required and the requirements for individual components to ensure the system's reliability and effectiveness. These requirements can also be specified in the fire protection concept and building permits.

Maintenance of an emergency lighting system must be carried out once a year.

For emergency lighting systems, whether self-contained, centralized, decentralized, low-power, etc., DIN VDE V 0108-100 requires measurement of the lighting values (according to DIN 5035-6 and DIN EN 1838).

This must be done before initial commissioning and then at least every 3 years.

ASRA 2.3 specifies the conditions under which emergency lighting is required for escape routes. Essentially, an emergency lighting system is required if safe exit from the workplace cannot be guaranteed in the event of a general lighting failure. Emergency lighting may be necessary, for example, in workplaces...

- ... which have a large number of people, many floors or areas with increased risk or confusing escape routes.
- ... which are used by people who know the area.
- ... in which large spaces have to be crossed (e.g. halls, open-plan offices or sales areas).
- ... that do not have daylight, e.g., rooms below ground level. [1]
